As stated in the *Federal Register* notice (77 Fed. Reg. 44704) published on July 30, 2012, USTR is prepared to receive petitions requesting waivers of competitive need limitations (CNLs) for the Generalized System of Preferences (GSP). The table below provides information on products that, based on eight-month (January-August 2012) trade data, may exceed CNLs for 2012. This information is provided as a courtesy for informational purposes only. Regardless of whether or not an article is included on this list, all determinations and decisions regarding CNLs will be based on full calendar-year 2012 import data with respect to each GSP-eligible article.
