# THE DOMINICAN REPUBLIC-CENTRAL AMERICA-UNITED STATES FREE TRADE AGREEEMENT

## DECISION OF THE FREE TRADE COMMISSION REGARDING THE SPECIFIC RULES OF ORIGIN OF ANNEX 4.1

DESIRING to maintain the consistency between Annex 4.1 of the Dominican Republic – Central America – United States Free Trade Agreement ("Agreement"), as amended, on the one hand, and each Party's tariff laws on the other; and

In accordance with Article 19.1.3(b) (ii) of the Agreement, the Commission hereby decides to modify Annex 4.1 (Specific Rules of Origin) of the Agreement as follows:

- 1. Annex 4.1 is modified as set forth in Annex A to this Decision;
- 2. Appendix 4.1-A is modified as set forth in Annex B to this Decision; and
- 3. Appendix 4.1-D is inserted as set forth in Annex C to this Decision.

These modifications shall take effect 60 days after the date on which all Parties to the Agreement have notified the Depositary in writing that they have approved them, in accordance with the applicable legal procedures of each Party.


