Not less than once per year thereafter, unless otherwise decided by the United States and Brunei Darussalam, Brunei Darussalam shall provide an update or new report, as appropriate, with information on changes in the information provided to the United States regarding its textiles and apparel production or other information on the sector that the United States and Brunei Darussalam may decide.
- 4. No later than 180 days after entry into force of this agreement and annually thereafter, unless otherwise decided, Brunei Darussalam shall provide to the United States data on its imports and exports of textile and apparel goods, including: the tariff classification; value; volume; and country of import or export.
- 5. Brunei Darussalam and the United States may amend this agreement by mutual decision.
