

**COMMON GUIDELINES FOR  
THE INTERPRETATION, APPLICATION, AND ADMINISTRATION  
OF CHAPTER FOUR AND THE RELEVANT PROVISIONS  
OF CHAPTER THREE OF THE UNITED STATES - CHILE  
FREE TRADE AGREEMENT**

Pursuant to Article 4.17 of the United States – Chile Free Trade Agreement (the “Agreement”), the Government of the United States and the Government of Chile (hereinafter the “Party” or “Parties” as appropriate) adopt the following common guidelines for the interpretation, application, and administration of Chapter Four and the relevant provisions of Chapter Three of the Agreement:

**Section A: Rules of Origin**

**Transit and Transshipment**

Further to Article 4.11.2, the customs authority of the importing Party may request that an importer claiming preferential tariff treatment under the Agreement for a good provide documents or any other information to demonstrate to the satisfaction of the customs authority of the importing Party that any production or operation performed outside the territories of the Parties does not render the good non-originating as provided by Article 4.11.1. Such documents or information may include, but is not limited to, bills of lading, packing lists, commercial invoices, and customs entry and exit documents. The failure of the importer to provide documents or information may result in a denial of the claim for preferential tariff treatment for such good.

**Section B: Origin Procedures**

**Claims of Origin**

1. When making a claim for preferential tariff treatment in accordance with Article 4.12.1, an importer shall be prepared to submit, at the request of the customs authority of the importing Party, the following information:

- (a) if known, the legal name, address, telephone number, and e-mail address of the producer;
- (b) if different from the producer, legal name, address, telephone number, and e-mail address of the exporter of the good;
- (c) if known, the legal name, address, telephone number, and e-mail address of the importer of record of the good;
- (d) a description of the good(s) for which preferential tariff treatment is claimed, which must be sufficiently detailed to relate to the invoice and the Harmonized System nomenclature;

- (e) when a certificate of origin covers multiple shipments of identical goods as provided in Article 4.13.3, the specific dates for which the certificate of origin covers such goods;
- (f) Harmonized System classification at the six digit level for the goods for which preferential tariff treatment is claimed;
- (g) the provisions of Article 4.1 of the Agreement pursuant to which the goods are entitled to preferential tariff treatment; and
- (h) if a certificate of origin is the basis for the claim of origin, the following:
  - (i) name, address and telephone number of the authorized official or legal representative signing the certificate of origin;
  - (ii) date the certificate of origin was signed, and signature of the person executing the certificate of origin either by handwritten or electronic means, and
  - (iii) the following statements, which shall be attested to by the person signing the certificate of origin:
    - (1) The information in the certificate of origin is true and accurate, and I assume the responsibility for proving such representations; I understand that I am liable for any false statements or material omissions made on or in connection with this document;
    - (2) I agree to maintain and present upon request, documentation necessary to support this certification, and to inform, in writing, all persons to whom this certificate was given of any changes that could affect the accuracy or validity of the certification; and
    - (3) The good(s) are originating under the United States – Chile Free Trade Agreement; there has been no subsequent production or any other operation outside the territories of the Parties other than unloading, reloading, or any other operation necessary to preserve the good(s) in good condition or to transport the good to the territory of one of the Parties.

2. Further to Articles 4.12.2 and 4.14.1 the customs authority of the importing Party may request sales contracts, sales receipts, factory production records, or any other

documents or information that substantiates the claim for preferential tariff treatment. Where an importer is basing a claim for preferential tariff treatment on an exporter's or producer's certificate of origin or knowledge and the importer seeks to demonstrate that the good qualifies as originating by submitting business confidential or other sensitive information, including cost and sourcing information, the customs authority of the importing Party shall allow the exporter or producer to submit such information directly to the customs authority of the importing Party, rather than through the importer.

3. For purposes of Article 4.13.2(b), the term "knowledge" includes personal or direct knowledge of the exporter or importer that the good is originating (*e.g.*, actual visits to the factory where the good was produced).

4. Further to Article 4.13.3, a certificate of origin may be applicable to:

- (a) a single importation of a good, including one shipment that results in the filing of one or more import declarations; or
- (b) multiple importations of identical goods into the territory of one of the Parties that occur within a specified period, not exceeding twelve (12) months, set out in the certificate of origin.

5. With respect to a certificate of origin described in Article 4.13.3, if, as a result of verification undertaken pursuant to Article 4.16, the customs authority of the importing Party denies a claim for preferential tariff treatment because the good does not qualify as originating, that Party may consider such certificate of origin invalid with respect to identical goods imported by that importer after the date on which that Party issued the written determination described in Article 4.16.3.

6. Further to Article 4.13.7, if the customs authority of the importing Party considers that an importation has been carried out or planned for the purpose of evading compliance with the rules and procedures governing claims of origin under the Agreement, the customs authority of the importing Party may request that a certificate of origin or other information demonstrating that the good qualifies as originating be submitted within thirty (30) days of the date of the request.

7. Further to Article 4.13.7(b), and subject to meeting other requirements of each Party's domestic law, no certificate of origin or other information is required for a non-commercial or personal importation of a good, *i.e.*, the importation of the good into the United States or Chile is for personal use rather than for the purpose of sale, or any commercial, industrial, or other like use.

8. Further to Articles 4.15 and 5.5, and only under exceptional circumstances, when a certificate of origin forms the basis for a claim for preferential tariff treatment, and

- (a) the customs authority of the importing Party has a reasonable suspicion of unlawful activity; and

- (b) an importer has not complied with a request from the customs authority of the importing Party to provide a copy of a certificate of origin,

the customs authority of the importing Party may request that the exporting Party provide a copy of such certificate to the customs authority of the importing Party.

9. Further to Article 4.14, each Party shall provide that the importer may maintain the records and documents specified in Article 4.14.3 in an electronic format that allows for prompt retrieval and printing.

10. Further to Article 4.15, each Party shall provide that the exporter or producer may maintain the records and documents specified in Article 4.15.2 in an electronic format that allows for prompt retrieval and printing.

11. Further to Article 4.16, if the customs authority of the importing Party conducting a verification determines that there is a reasonable suspicion of unlawful activity related to its laws and regulations governing importations, it may request assistance from the exporting Party pursuant to Articles 5.5 and 5.6. in order to obtain the information, relevant records and documents specified in article 4.15.2.

## **Section C: Textiles and Apparel**

### **Preferential Tariff Treatment for Non-Originating Cotton and Man-made Fiber Fabric Goods**

1. Pursuant to Article 3.20.8, importations of certain non-originating cotton and man-made fiber fabric goods up to a specified annual quantity shall be accorded preferential tariff treatment, if all applicable requirements are satisfied. A list of the tariff headings and subheadings of such goods is set forth in Annex 1 of these Common Guidelines.

### **Preferential Tariff Treatment for Non-Originating Cotton and Man-made Fiber Apparel Goods**

2. Pursuant to Article 3.20.10, importations of certain non-originating cotton and man-made fiber apparel goods up to a specified annual quantity shall be accorded preferential tariff treatment, if all applicable requirements are satisfied. A list of the tariff headings and subheadings of such goods is set forth in Annex 2 of these Common Guidelines.

3. A table correlating the tariff headings and subheadings of the tariff schedules of the United States and Chile set forth in Annexes 1 and 2, as necessary, is set forth in Annex 3 of these Common Guidelines.

### **Certification for Tariff Preference Level**

4. Pursuant to Article 3.20.12, a Party may require that an importer claiming preferential tariff treatment for a textile or apparel good under Article 3.20.8 or 3.20.10 present, at the time of importation, a certification of eligibility for such preferential tariff

treatment under such paragraph. The importer shall prepare such certification of eligibility, in accordance with subparagraphs (a) through (d).

- (a) The certification need not be in a prescribed format, but must be made in writing or transmitted electronically through the use of an electronic system authorized by the customs authority of the importing Party for that purpose;
- (b) The certification must be signed and dated by the importer, or by an authorized official or legal representative of the importer that has sufficient knowledge of the relevant facts, and must include:
  - (i) the legal name, address, telephone number, and e-mail address of the importer of record of the good;
  - (ii) if different from the producer, the legal name, address, telephone number, and e-mail address of the exporter of the good;
  - (iii) if known, the legal name, address, telephone number, and e-mail address of the producer of the good;
  - (iv) a description of the good that is of sufficient detail to permit identification of such good in the invoice and under the Harmonized System;
  - (v) the six-digit subheading level classification number of the good under the Harmonized System, as well as each other classification number of the good beyond the six-digit level set forth in the tariff schedule of a Party; and
  - (vi) in the case of a single shipment, the commercial invoice number covering the goods;
- (c) The certification must include the following statement, as completed by the importer:

“I certify as follows:

The information in this certification is true and accurate. I understand that I am liable for all false statements or material omissions made on or in connection with this certification.

I agree to present on request documentation necessary to support this certification, and to inform, in writing, all persons to whom this certification is given of any changes that could affect its accuracy or validity, and to maintain such certification for a period of five years after the date of importation of the good.

The goods for which this claim of preferential tariff treatment is made were produced in the territory of one or both of the Parties and satisfy the requirements for such treatment

under Article 3.20.8 or 3.20.10, as the case may be, of the United States – Chile Free Trade Agreement.

These goods have not been subject to subsequent production or any other operation outside the territories of the Parties, other than unloading, reloading, or any other operation necessary to preserve them in good condition or to transport them to the territory of the importing Party.

- (d) If the certification is not made in the language of the importing Party, the importer shall provide to the importing Party’s customs authority, on request, a written translation of the certification in that language.
- 5. (a) Except as otherwise provided in subparagraph (b), an importer shall not be required to prepare and submit a certification of eligibility for preferential tariff treatment with respect to a non-commercial or commercial importation of a good whose customs value does not exceed US\$2,500, or the equivalent amount in Chilean currency, provided that, unless waived by the importing Party’s customs authority, the importer or the importer’s authorized official or legal representative includes on, or attaches to, the invoice or other document accompanying the shipment the following signed statement:

“I hereby certify that the goods covered by this shipment are eligible for preferential tariff treatment under Article 3.20.8 or 3.20.10 of the United States – Chile Free Trade Agreement.

- (b) If the importing Party’s customs authority determines that an importation described in paragraph (a) may reasonably be considered to have been carried out for the purpose of circumventing the requirements governing claims for preferential tariff treatment under Article 3.20.8 or 3.20.10, such customs authority shall notify the importer in writing that, with respect to such

importation, the importer must, within 30 days of such notice, submit a further certification that the good qualifies for preferential tariff treatment. Failure timely to submit such certification will result in denial of the claim for preferential tariff treatment.
