GSP Program

- Enhanced access to U.S. market
- Expanded choices for U.S. industries & consumers
- Provides duty-free treatment for about 3,500 products from Ukraine and 121 other countries
- \$17.4 billion in total U.S. GSP imports (2014)
- GSP program authorized through December 2017

GSP Eligibility Criteria for Countries

Intellectual Property Right provisions: the extent to which a country is providing adequate and effective protection of intellectual property rights.

Labor provisions: whether a country has taken or is taking steps to afford to workers in that country internationally recognized worker rights.

Refunds of Duties Paid

- GSP was renewed retroactively to July 31, 2013
- CBP will reimburse U.S. importers for tariffs paid on eligible products during the gap period (July 31, 2013 to July 29, 2015).

GSP Program: Eligible Products

Eligible

- Many manufactured items & inputs
- Jewelry
- Many agricultural products
- Chemicals
- Minerals
- Marble
- Carpets

Ineligible

- Most textiles & apparel
- Watches
- Footwear
- Some gloves & leather goods



How many products are eligible for GSP duty-free treatment?

MFN duty-free products, 3,868, 36%

Dutiable imports, 1,868, 17%

GSP-eligible imports (LDCs), 1,472, 14%

GSP-eligible imports (all), 3,509, 33%

U.S. and Ukraine: 2014 Trade

- U.S. imports from Ukraine: \$903 million
- GSP imports: \$26 million (3% of total imports)

Overall GSP utilization rate: 27%

How to Qualify for Duty-Free Treatment under GSP

- Must be a GSP-eligible product
- Must be a product or growth of Ukraine
 - If using non-Ukrainian inputs, local content & processing must be ≥ 35% of the value
 - Must import directly into the U.S. w/o entering commerce of another country
- Benefit must be claimed by importer
- Keep production/accounting records to assist importer to verify GSP claim




