# Office of the United States Trade Representative FY 2020 Service Contract Inventory Analysis

#### **Background**

The Office of the United States Trade Representative (USTR) is an agency of more than 260 committed professionals with specialized experience in trade issues and regions of the world. We negotiate directly with foreign governments to create trade agreements, to resolve trade disputes, and to participate in global trade policy organizations. We also meet with state and local governments, business groups, legislators and public interest groups to gather input on trade issues and to discuss the President's trade policy positions. USTR was created in 1962 and has offices in Washington, Geneva, Beijing, Mexico, and a representative to the U.S. EU Mission in Brussels.

Our mission: American trade policy works toward opening markets throughout the world to create new opportunities and higher living standards for families, farmers, manufacturers, workers, consumers, and businesses. The United States is party to numerous trade agreements with other countries, and is participating in negotiations for new trade agreements with a number of countries of the world.

The Office of the U.S. Trade Representative (USTR) is responsible for developing and coordinating U.S. international trade, commodity, and direct investment policy, and overseeing negotiations with other countries. The head of USTR is the U.S. Trade Representative, a Cabinet member who serves as the president's principal trade advisor, negotiator, and spokesperson on trade issues.

USTR is part of the Executive Office of the President. Through an interagency structure, USTR coordinates trade policy, resolves disagreements, and frames issues for presidential decision. The U.S. Trade Representative is on the Board of Directors of the Millennium Challenge Corporation, is a non-voting member of the Export-Import Bank Board of Directors, and a member of the National Advisory Council on International Monetary and Financial Policies.

#### Scope

Section 743 of Division C of the FY 2010 Consolidated Appropriations Act, P.L. 111-117, requires civilian agencies to prepare an annual inventory of their service contracts and analyze their inventory to determine if the mix of Federal employees and contractors is effective or if rebalancing may be required. The service contract inventory is a tool for assisting agencies in better understanding how contracted services are being used to support agency missions and operations and whether contractors' skills are being utilized in an appropriate manner.

For the FY 2020 analysis, USTR identified the PSCs listed in the table below as the PSCs with the greatest percentage of spending.

## Methodology

All five PSC's analyses were conducted in the same manner. A total of five contracts were analyzed. Interviews and surveys were conducted with COR's and/or relevant managers. Interviews and surveys were conducted to determine the following: the approximate number of employee equivalents performing under each contract; if the contractor was performing inherently governmental functions; if there are sufficient government personnel for oversight of the contractor's performance; if the contractor is performing critical functions; and whether the COR communicated the SAM service contract reporting requirement to the contractors.

#### **Findings**

The table below lists USTR's service contract inventory awarded during FY 2020 with action obligation values exceeding the Simplified Acquisition Threshold by PSC.

### **Role Contracted Services Play in Achieving Agency Objectives**

#### PSC B506: Special Studies/Analysis –Data (Other than scientific) -\$3,769,528.42

The inventory includes one contract within this PSC, representing 32% of the total reportable obligations within the inventory. Services provided under this PSC are for contracted technical analyst and Tariff Classification Experts in support of the 301Tariff Exclusions process.

The contractors under this PSC provided are for technical analyst and Tariff Classification Experts in support of the 301Tariff Exclusions process.

The contractors provided expert technical analysis of industry tariff exclusion requests submitted by impacted U.S. businesses submitted to USTR and development of tariff carve outs pursuant to the President's Section 301 Investigation into China's forced technology transfer practices and assessment of tariffs on exports from China. These functions were not performed at USTR in the past and were not performed on the scale with the same duration as they are being performed formed now by contractors. This function supports a new USTR effort and is expected to be temporary. The function does not require in any way that contractors exercise discretion in applying government authority; it does not require the interpretation and execution of the laws of the U.S.; and does not involve the oversight of monetary transactions. This function is new and temporary. EOP Office of Administration supported USTR with the SBA approved acquisition of this contract.

#### PSC N099: Installation of Equipment-Miscellaneous-\$1,841,339.27

The inventory includes one contract within this PSC, representing 16% of the total reportable obligations within the inventory. Services provided under this PSC included providing Identity Credentialing and Access Management (ICAM) services for physical access control systems and software for USTR. Upgrades USTR's physical access control systems and software for future connection to the Executive Office of the President's (EOP) security system including their Physical Access Control (PACS) system and smart card issuance system, General Services Administration (GSA) USAccess. Provides the access control software and support services required to transition, deploy, operate, and maintain the physical access control system.

The United States Trade Representative (USTR) Office of Security (OSY) is continuing to pursue the acquisition of Identity Credentialing and Access Management (ICAM) services from a certified commercial provider to centralize and modernize USTR's Security Management System (SMS) comprised of Physical Access Control System (PACS), Closed Circuit Television (CCTV) cameras, Visitor Management, Intrusion Detection System (IDS), and Duress Alarms. Additionally, to ensure compliance with existing federal government standards for the use of smart cards the PACS is configured to support the GSA approved 200-bit smart card format as described in FIPS 201 and NIST 800-116. The modernization of PACS will streamline processes and ensure the safety and security of USTR employees and contractors across three separate facilities. USTR Security has one contract to provide operation and maintenance (O&M) for SMS. (UST-GEN-P17-0012; Prism International, LLC) PSC code N099, Installation of Equipment – Miscellaneous valued at \$1,841,339.27. This is the last option year for the SMS contract and our goal is to onboard an FTE to provide O&M for SMS which could save the agency an excess of \$800K per year.

The USTR OSY reviewed multiple contracts and contractor capabilities to include their certifications to manage GSA compliant hardware and software, in cooperation with colleagues at different agencies to include EOP/Office of Administration (OA). USTR has one contract to provide operational and maintenance services for SMS.

The USTR OSY determined through extensive research contractor expertise for implementing and maintaining SMS required a new strategy to manage the lifecycle in lieu of conducting intermittent upgrades and patches. The USTR PACS was configured as a standalone solution with no consideration

for federal mandates such as OMB M-11-11 and specific ICAM requirements. The current National Institute of Standards (NIST) special publications that govern the use of PACS require the system to be centralized and modernized to incorporate evolving technologies using the Personal Identity Verification (PIV) card. Federal oversight is required to be successful with implementing these federal mandates and do not afford contractors to perform critical functions that affect USTR's ability to keep USTR employees secure and safe at any of the three facilities. Three contractors are on contract to provide O&M for SMS and two FTEs are committed to overseeing their daily responsibilities.

The USTR OSY utilized market research by working with partner agencies and OA to identify qualified vendors to implement and maintain SMS while complying with federal and agency specific requirements. Additionally, USTR OSY gathered independent cost estimates to develop performance objectives based on NIST and ICAM requirements to manage SMS. This FY the agency upgraded, installed and consolidated multiple CCTV monitoring systems, replaced obsolete card readers, upgraded IDS systems and programming, and improved software capabilities for PACS by over 40%. Implemented over three separate security countermeasures for 100% of USTR operated SCIFs.

Future plans include upgrades, removal of redundant systems, and installation of new security countermeasures for three separate facilities. This includes adding five SECRET-level rooms and an additional SCIF all which require CCTV, PACS, and IDS capabilities. Additionally, upgrade new visitor management system that include peripherals to validate REAL ID requirements and official passports. Lastly, replace antiquated duress buttons with modern technology compatible with SMS for USTR headquarters.

## PSC D302: IT and Telecom-Systems Development -\$1,023,715.31 + \$3,010,562.23 = \$4,034,277.54

The inventory includes one contract within this PSC, representing 9% + 26% for a total of 35% of the total reportable obligations within the inventory. Services within this PSC provides supports the application development needs of USTR and addresses specific rapid development requests to meet USTR policy objectives, i.e. the processing of China Tariff exclusion requests.

The Executive Office of the President (EOP), Office of United States Trade Representative (USTR), seeks expertise, knowledge, and implementation support for the deployment, administration, and enhancement of all Salesforce applications across USTR. These operational needs and enhancements may range in size. The scope of this PWS refers to the following AppDev ID/IQ CLINs: CLIN 3 (Application Administration, Operations, and Support – Severable), CLIN 4 (Quality Assurance and Testing – Severable), CLIN 5 (Quality Assurance and Testing – Non-Severable), CLIN 6 (Application Licenses and Subscription – Non-Severable). The contractor is responsible for ensuring that the Salesforce application is fully supported, administered, patched, maintained, evaluated, documented, tested, and enhanced as necessary to meet the government's operational requirements.

The USTR reviewed multiple contracts and contractor capabilities to include their certifications to manage GSA compliant hardware and software, in cooperation with colleagues at different agencies to include EOP/Office of Administration (OA). USTR has one contract to provide operational and maintenance services for Salesforce.

The contractor has performed well and, in some cases, exceeding expectations. All the work was performed by its own staff with no assistance by USTR's staff or other contractor employees. It has been determined that no actions are needed at this time.

## PSC R418: Support – Professional: Legal -\$2,012,785.60

The inventory includes two contracts within this PSC, representing 17% of the total reportable obligations within the inventory. Services provided under this PSC is for paralegal contractors. Services provided under this PSC included providing paralegal support services for paralegals with the following:

-Undergraduate Degree, and the ability to read and conduct research in English and Mandarin.

- -Undergraduate Degree, and the ability to read and conduct research in English and Korean.
- -Undergraduate Degree, and the ability to read and conduct research in English and Russian.
- -Undergraduate Degree, and the ability to read and conduct research in English and Turkish.
- -Undergraduate Degree, in Accounting, Economics, or Finance, plus 1+ year International Trade experience.

The contractor's paralegals provided for the Interagency Center on Trade Implementation, Monitoring, and Enforcement legal research and analysis with the specific abilities to research in English and potentially other languages as needed, such as, but not limited to Korean, Mandarin and Russian. Contractors are also processing public comments and exclusion requests submitted to USTR in the course of the President's Section 301 Investigation into China's forced technology transfer practices.

USTR has determined that the function does not require the exercise of discretion in applying government authority; it does not require the interpretation and execution of the laws of the U.S.; and does not involve the oversight of monetary transactions. The contractors have performed well. Contract was continued and option year was exercised. No weaknesses or challenges identified during this period of performance.
