

GSP-Eligible Products of Possible Interest to Tunisian Producers

The following is a sampling of some GSP-eligible products that may be of special interest to Tunisian producers. It is NOT a complete or authoritative list. To determine whether a specific product is eligible for GSP, go to http://dataweb.usitc.gov/scripts/tariff_current.asp and enter a short description of the product. If the product shows an “A” in the heading for GSP under “preferential tariff program,” it is a GSP-eligible product. An “A+” means it is eligible only for least developed country (LDC) beneficiaries of GSP; Tunisia is not an LDC beneficiary of GSP. This website also shows the non-GSP (“most-favored-nation”) duty rate for the product and provides links to trade data related to U.S. imports of the product.

Lists of GSP-eligible products can also be found on the USTR web site: www.ustr.gov. Go to “Trade Topics” from the drop-down menu in the banner, then click on “Preference Programs.” On the left side of the page, click on “Generalized System of Preferences” and then on “GSP Program Information.”

10. Electrical parts and accessories

11. Miscellaneous

- inflatable mattresses
- inflatable vessels for pleasure or sport
- some woven silk fabrics

- iron oxides and hydroxides
- zinc sulfate

- handles and knobs for furniture
- plates, cups, saucers, soup bowls, etc.
- tableware

- gaskets and washers
- radial tires for buses or trucks
