
### Bolivia and the U.S. Generalized System of Preferences (GSP) Program

# May 2010

#### What is GSP?

The U.S. GSP program provides duty-free treatment for about 3,450 types of exports from Bolivia and 130 other developing countries. The purpose of the GSP program is to give these exports a competitive edge in the U.S. market. U.S. companies and customers are especially interested in buying goods through the GSP program because the exports are not charged tariffs upon entering the United States. These tariffs can range from 2% to 17% of the items' cost. U.S. imports under GSP in 2009 from all beneficiary countries totaled \$20.3 billion.

Many items are eligible for GSP duty-free treatment. These include most manufactured items, inputs used in manufacturing, jewelry, many types of carpets, certain agricultural and fishery products, many types of chemicals, marble, and minerals. Not eligible for GSP duty-free treatment are certain textiles and apparel; watches; some footwear, handbags, and other leather items; luggage; most cloths and sheets for kitchen and bedroom use; and work gloves. The chart below shows the percentage of product types entering the United States under the GSP program in 2008.



### How does an import receive GSP duty-free treatment?

A GSP-eligible import must meet the following requirements:

- be included on the list of GSP-eligible articles;
- be imported into the United States directly from Bolivia or pass through another country under a bill of lading
- be the growth, product, or manufacture of Bolivia;
- if imported materials are used to make the product, the cost of the Bolivian materials plus the cost of processing must equal at least 35% of the product's sales price;
- imported materials can count toward that 35% only if the imported materials are "substantially transformed" and then used to produce or manufacture the export; "substantially transformed" means that the imported items go through at least two types of changes in form from when they were first imported

• MOST IMPORTANTLY: The importer must request duty-free treatment under GSP by placing an "A," in front of the U.S. tariff line (HTSUS) number that identifies the imported article on U.S. Customs Entry Form 7501 (see Attachment 1).

### What documents are needed to ensure GSP duty-free treatment?

For agricultural exports:

- 1. Producer's statement verifying which town and farm the product is grown on
- 2. Description of product and quantity
- 3. Dated invoices for costs incurred

To verify 35% rule of origin rule:

- 1. Dated invoices for materials used to produce good and from where
- 2. Description of product and quantity

If processing operations are involved:

- 1. Description of processing and location
- 2. Direct costs of processing operations

NOTE: Must keep all documents for at least 5 years

## **Bolivia's Use of GSP Preferences**

U.S. imports from Bolivia under GSP were \$123.9 million in 2009, accounting for 24.6% of overall U.S. imports from Bolivia in 2009 (see Attachment 2). In 2008, Bolivia utilized 98.2% of potential GSP benefits and in 2009 utilized 98.8%. During 2009, Bolivia was the 28th greatest beneficiary of the GSP program. Products imported from Bolivia under GSP in 2008 and 2009 were diverse and included:

- Precious metal (other than silver) articles of jewelry and parts thereof, whether or not plated or clad with precious metal, nesoi<sup>1</sup> (HTS 71131950) (Tariff 5.5%)<sup>2</sup>
- Tungsten concentrates (HTS 26110060) (Tariff 37.5 cents/kg on tungsten content)
- Gold rope necklaces and neck chains (HTS 71131921) (Tariff 5%)
- Silver articles of jewelry and parts thereof, nesoi, valued over \$18 per dozen pieces or parts (HTS 71131150) (Tariff 5%)
- Precious metal (o/than silver) clasps and parts thereof (HTS 71131930) (Tariff 5.8%)
- Gold necklaces and neck chains (o/than of rope or mixed links) (HTS 71131929) (Tariff 5.5%)
- Doors of wood, other than French doors (HTS 44182080) (Tariff 4.8%)
- Cane sugar, raw, in solid form, w/o added flavoring or coloring, subject to add. US 5 to Ch.17 (HTS 17011110) (Tariff 1.4606 cents/kg less 0.020668 cents/kg for each degree under 100 degrees (and fractions of a degree in proportion) but not less than 0.943854 cents/kg)
- Gold (including gold plated with platinum), nonmonetary, in semi-manufactured forms (except gold leaf), nesoi (HTS 71081370) (Tariff 4.1%)
- Jewelry articles of precious or semiprecious stones, valued over \$40 per piece (HTS 71162015) (Tariff 6.5%)
- Precious metal (o/than silver) rope, curb, etc. in continuous lengths, whether or not plated/clad precious metal, for jewelry manufacture (HTS 71131910) (Tariff 7%)
- Nonconiferous wood continuously shaped along any of its ends, whether or not also continuously shaped along any of its edges or faces (HTS 44092905) (Tariff 3.2%)
- Oxides of boron; boric acids (HTS 28100000) (Tariff 1.5%)
- Tin, bars, rods, profiles and wire (HTS 80030000) (Tariff 3%)

- Palm hearts, otherwise prepared or preserved, nesoi (HTS 20089100) (Tariff 0.9%)
- Detonating caps, igniters or electric detonators (HTS 36030090) (Tariff 0.2%)
- Dried leguminous vegetables nesoi, shelled, if entered Sept. 1 through the following April 30, or withdrawn for consumption at any time (HTS 07139080) (Tariff 1.5 cents/kg)
- Dried leguminous vegetables nesoi, shelled, if entered for consumption during the period from May 1 through August 31, inclusive, in any year (HTS 07139060) (Tariff 0.8 cents/kg)
- Dried beans nesoi, shelled, if entered for consumption September 1 through April 30, or withdrawn for consumption at any time (HTS 07133940) (Tariff 0.8 cents/kg)
- Jewelry articles of precious or semiprecious stones, valued not over \$40 per piece (HTS 71162005) (Tariff 3.3%)
- Articles of wood, not elsewhere specified or included (HTS 44219097) (Tariff 3.3%)
- Handbags with or without shoulder strap or without handle, with outer surface of textile materials, wholly or in part of braid, of abaca (HTS 42022235) (Tariff 8.4%)
- Nonadhesive plates, sheets, film, foil and strip, noncellular, not combined with other materials, of polyethylene terephthalate (HTS 39206200) (Tariff 4.2%)
- Plywood sheet n/o 6 mm thick, at least one outer ply of nonconiferous wood, with face ply nesoi, not surface covered beyond clear/transparent (HTS 44123231) (Tariff 8%)
- Base metals clad with silver, not further worked than semi-manufactured (HTS 71070000) (Tariff 3.3%)
- Dried potatoes, whether or not cut or sliced but not further prepared (HTS 07129030) (Tariff 2.3 cents/kg)
- Base metal clad w/precious metal articles of jewelry and parts thereof, nesoi (HTS 71132050) (Tariff 5.2%)
- Cigars, cheroots and cigarillos containing tobacco, each valued 23 cents or over (HTS 24021080) (Tariff 57 cents/kg + 1.4%)
- Ceramic (o/than porcelain or china) arts. (o/than tableware/kitchenware/household & ornament. arts), nesoi (HTS 69149080) (Tariff 5.6%)
- Wood marquetry and inlaid wood; wooden articles of furniture, nesoi (HTS 44209080) (Tariff 3.2%)
- Plywood sheets n/o 6 mm thick, at least one outer ply of nonconiferous wood, surface covered other than clear or transparent (HTS 44123256) (Tariff 8%)
- Corn (maize), other than seed and yellow dent corn (HTS 10059040) (Tariff 0.25 cents/kg)
- Silversmiths' wares (other than for household/table/kitchen use & toilet and sanitary wares) of silver, nesoi (HTS 71141170) (Tariff 3%)
- Straps and strops of leather or of composition leather (HTS 42050040) (Tariff 1.8%)

### How to Export More Bolivian Products Using GSP Duty-Free Benefits

<u>Claim the GSP Savings</u>: Bolivian producers and exporters need to make sure that they mark U.S. customs entry form 7501 with an "A" before the product's tariff number to ensure GSP duty-free treatment (see Attachment 1).

<u>Export Products Duty-Free to the United States that are Currently Exported Elsewhere</u>: Bolivia exports certain goods to other countries, but not the United States in large amounts. Many of these items are eligible for duty-free treatment in the United States:

- Oilcake and other solid residues, resulting from the extraction of vegetable fats or oils, of sunflower seeds (HTS 23063000) (Tariff \$.45/kg.)
- Ceramic roofing tiles (HTS 69051000) (Tariff 13.5%)
- Pasta nesoi (HTS 19023000) (Tariff 6.4%)
- Slide fasteners, not fitted with chain scoops of base metal (HTS 96071900) (Tariff 13%)
- Lubricating greases from petro oil/bitum min/70%+ by wt. fr. petro. oils but n/o 10% by wt. of fatty acid salts animal/vegetable origin (HTS 27101935) (Tariff 5.8%)

- Hair-nets of any material, whether or not lined or trimmed (HTS 65051000) (Tariff 9.4%)
- Slide fasteners, fitted with chain scoops of base metal (HTS 96071100) (Tariff 10%)
- Sparkling wine, made from grapes (HTS 22041000) (Tariff 19.8 cents/liter)
- Preparations for perfuming or deodorizing rooms, including odoriferous preparations used during religious rites, nesoi (HTS 33074900) (Tariff 6%)
- Fittings of plastics, for plastic tubes, pipes and hoses, nesoi (HTS 39174000) (Tariff 5.3%)
- Office or school supplies, of plastics (HTS 39261000) (Tariff 5.3%)
- Articles for the conveyance or packing of goods, of plastics (HTS 39239000) (Tariff 3%)
- Lead-acid storage batteries of a kind used for starting piston engines (HTS 85071000) (Tariff 3.5%)
- Iron or steel, helical springs, suitable for motor-vehicle suspension (HTS 73202010) (Tariff 3.2%)
- Other live plants nesoi, other than those with soil attached to roots (HTS 06029090) (Tariff 4.8%)
- Glass containers for convey/pack perfume/toilet preps & containers with/designed for ground glass stopper, not made by automatic machine (HTS 70109030) (Tariff 5.2%)
- Flour, meal and powder of Chinese water chestnuts (HTS 11062010) (Tariff 8.3%)
- Polystyrene, expandable, in primary forms (HTS 39031100) (Tariff 6.5%)
- Nonadhesive plates, sheets, film, foil and strip, noncellular, not reinforced or combined with other materials, of polymers of ethylene (HTS 39201000) (Tariff 4.2%)
- Sacks and bags (including cones) for the conveyance or packing of goods, of polymers of ethylene (HTS 39232100) (Tariff 3%)
- Berries, other than blueberries and strawberries, otherwise prepared or preserved, nesoi (HTS 20089920) (Tariff 4.5%)
- Apricots, dried (HTS 08131000) (Tariff 1.8 cents/kg)

<u>Further Develop Capacity of Export Items Eligible for GSP</u>: Bolivia produces and exports to other countries small quantities of items, especially agricultural products and handicrafts, that could eventually be eligible for GSP treatment if exported to the U.S. market, including:

- cocoa powder
- wine
- potatoes
- dried fruits and berries
- nuts
- dried flowers
- traditional games
- wind, string, and drum musical instruments

- paintings, sculpture, and wall hangings
- wood picture frames
- many types of carpets, kilims, and rugs
- various types of hats
- wooden statuettes, boxes, and other wood items
- certain baskets and handbags of bamboo, rattan, palm leaf and vegetable material
